## **Commercial Circular No. 104(G)/2024**

Date: 14.03.2024

**Sub:** Commercial notification of 34<sup>th</sup> rake of BOXNHL wagons (61 wagons including 03 spare wagons) and 01 B/Van of M/s Adani Logistics Limited under General Purpose Wagon Investment Scheme (GPWIS).

- 1) Railway Board vide letter No. 2018/TC(FM)/04/12 dtd.10.03.2023 have granted approval to M/s Adani Logistics Ltd to procure and operate 05 BOXNHL rakes (including 4% spare wagons) and 05 Brake Vans. In this regard, the customer has executed GPWIS agreement No.PCCM/GPWIS/ADANI/2023/8 on 13.07.2023 with this office.
- 2) The details of the rakes of the party already inducted under GPWIS are as below:

- 3) Now, M/s Adani Logistics Limited has handed over 5<sup>th</sup> BOXNHL rake under Railway Board's approval letter dtd.10.03.2023 {cited at Sl. No.10 of the aforementioned table} [34<sup>th</sup> rake in total] consisting of 61 BOXNHL wagons (one rake including 03 spare wagons) and one Brake Van. The list of the wagons is enclosed as Annexure-1.

- 4) The approved circuits for movement of the rake are as under:

- 5) M/s Tata Steel Ltd (TISC), M/s Tata Steel Long Products Ltd (TSIL), M/s Tata Metaliks Ltd (TML), M/s Neelachal Ispat Nigam Ltd (NINL), M/s JCAP Co. Pvt. Ltd. (JCAP) and M/s T M International Logistics Ltd (TMIT) will be authorized users of this rake.
- 6) The subject rake will not be merged in IR's pool of wagons and will be distinctly indicated through a colour scheme. The rake so inducted shall run on aforementioned circuits only.
- 7) Maintenance of these wagons will be undertaken by IR on payment as per GPWIS agreement No. PCCM/GPWIS/ADANI/2023/8 dtd.13.07.2023 executed with M/s Adani Logistics Ltd. The subject rake will be maintained at maintenance depot situated at Adityapur (ADTP) of South Eastern Railway.
- 8) For each loaded rake of M/s Adani Logistics Ltd (consisting of wagons mentioned in Annexure-1), RRs are to be marked as "M/s Adani Logistics Ltd's rake under GPWIS".

- 9) Under GPWIS, M/s Adani Logistics Ltd is eligible to get a freight rebate of 10% on the Base freight rate prevailing at the time of booking. This freight rebate will be granted whenever the rakes move in loaded condition in the approved circuit. Modalities for granting rebate under GPWIS is as below:
- a) When the investor i.e. M/s Adani Logistics Ltd pays the freight either as Consignor or Consignee the rebate shall be granted on the RR itself.
  - b) When the freight is paid by authorized user as Consignor or Consignee, then the rebate amount will be credited to "Deposit Miscellaneous" account specially created under a separate head for GPWIS repayment.
  - c) Similarly, when the rake is loaded in the empty direction by Railway as per para 5.13.1 of GPWIS agreement, the rebate amount will be credited to "Deposit Miscellaneous" account.
- 10) The amount of freight so accumulated in "Deposit Miscellaneous" will be reimbursed to party on quarterly basis through reconciliation.
- 11) CGS/Station In charge of concerned loading/unloading point shall maintain a separate record of each movement of GPWIS rakes of M/s Adani Logistics Ltd. As and when required, a joint team consisting of CGS/Station In charge, CMI and TIA will calculate freight rebate applicable under the scheme for each RR and submit their report to PCCM/ECOR with details of the movement.
- 12) The subject BOXNHL rake will be governed by GPWIS Agreement No. PCCM/GPWIS/ADANI/2023/8 dtd.13.07.2023 and GPWIS policy issued by Railway Board vide circular No. Freight Marketing Master Circular/GPWIS/2018/0 dtd.26.04.2018 {PCCM/ECOR's Commercial Circular No.88(G)/2018 dtd.01.05.2018} and corrigendum/ addendum thereto issued by Railway Board from time to time.
