Sub: Haulage Charges for postal traffic for the year 2024-25.

Ref: Railway Board's Freight Marketing Circular No. 03 of 2023
dated 06.03.2023.

Haulage charges for Postal traffic carried in Postal Vans and Non-Postal Vans for the year 2023-24 was revised vide Freight Marketing Circular no. 03 of 2023 dated 06.03.2023.

Ministry of Railways have now decided to revise the Haulage charges for Postal Traffic carried in Postal Vans and Non-Postal Vans for the year 2024-25 as under:

Distance Slabs	Haulage charges for the Postal Traffic (2024-25) (Rate in ₹ Per berth per Km)
0-500 Km	₹1.26
501-1,000 Km	0.80 subject to minimum realization of haulage charges applicable on distance of 500 Kms (Subject to minimum of ₹630)
1,001 Km and above	0.67 subject to minimum realization of haulage charges applicable on distance of 1000 Kms (Subject to minimum of ₹800)

- Point to point charges shall be rounded off to the next multiple of five.
- Other terms and conditions mentioned in the letter dated 19.02.2007 as revised from time to time for charging of postal traffic, billing and payment shall remain unchanged.
- This issues with the concurrence of the Finance Commercial Directorate of Ministry of Railways.
- Necessary instructions may be issued to all concerned immediately.


