Ref: Rates Circular No. 14 of 2021 dated 05.04.2021 and its Corrigenda No. 01 dated 05.04.2022; and No. 02 dated 05.04.2023.

1. Please refer to Board's Rates Circular and its Corrigenda cited under reference wherein charging of JCB was notified as Motor Vehicles under Group No. 25 (m) of Goods Tariff No. 49 Part I (Vol. II), which was initially valid up to 05.04.2022 and was further extended up to 05.04.2023.
2. The last extension is valid up to 05.04.2024, which was granted in terms of Corrigendum No. 02 to Rates Circular No. 14 of 2021 dated 05.04.2023.
3. The matter has been reviewed and it has been decided by the Competent Authority to extend the validity of the same beyond 05.04.2024 for a further period of one year i.e. up to 04.04.2025.
4. JCB loading railways shall provide report indicating the impact of these instructions.
5. This issues with the concurrence of Finance Directorate of Ministry of Railways.

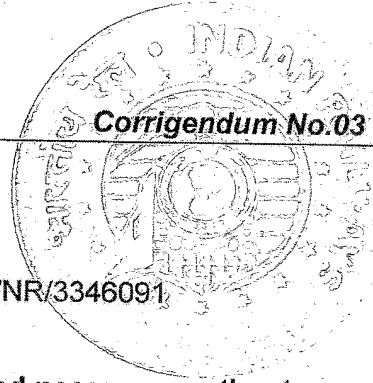
