Extract of the Railway Board's letter No. 2020/TC(FM)/11/19-(Pt-I) dated 01.04.2024 is reproduced below for information and necessary action please:-

“Please refer to Railway Board's under reference, wherein DRMs of the originating Divisions have been authorized to expand the Proof of Concept of “Joint Parcel Product(JPP)” of India Post and Indian Railways, by earmarking space in SLR of any scheduled passenger-carrying train, subject to certain conditions stipulated therein, and that these instructions were remained in effect till 25.03.2024.

The Competent Authority has decided that the above mentioned instructions shall remain in effect for **further period of 06 months i.e. upto 24.09.2024.**

Zonal Railways may take necessary action accordingly. Action taken in this regard may also be intimated to this office.

This issues in consultation with Finance Directorate of Ministry of Railways”.
