Sub: Checklist for the guidance of Liaison Officer.

During inspections of reservation/roster register of some of the railways, few anomalies were noticed in maintenance of roster/ reservation registers. It has also come to the notice that Some liaison officers are not aware of the procedure and the area to be seen while vetting the reservation/roster register. Hence, for the guidance & convenience of Liaison officers the following points in the form of checklist is prepared.

It is desired to follow the checklist as detailed below while vetting the reservation/roster register.

- 1. Maintenance of roster / reservation register:
 - a) As per Recruitment Rules.
 - b) Separate roster registers for direct recruitment & promotion.
 - c) Expanded or contracted as per increase or decrease in cadre strength.
 - d) Correctly filled up which should indicate name of post, cadre strength, method of recruitment, percentage of post of SC/ ST/OBC/EWS as per cadre strength.
- 2. Total number of points in the register /roster shall be equal to number of posts in the cadre.
- 3. All points in the cadre strength are to be filled before making the replacement in case of large cadre.
- 4. All columns of roster/reservation register should be filled properly.
- 5. All entries in the register should be in handwritten form and no pasting should be allowed.
- 6. No corrections in the roster register after vetting by Cadre Controlling Authority (CCA). In case of corrections if any, the same should again be certified by CCA &L.O.
- 7. Erasing / Overwriting is to be avoided.



- 8. Summary indicating cadre strength, representation of SC/ST/OBC, SC/ST appointed/promoted on their own merit, shortfall & backlog of SC/ST/OBC mentioned in the roster/reservation register after every appointment / promotions & should be jointly signed by CCA & L.O.
- 9. In case any reserved post remain vacant due to non-availability of candidates in particular grade, the vacant post is to be operated in lower grade by downgrading the same & CCA to be advised accordingly.
- 10. Entry like own-merit, superannuation, death, VRS, promotions, deputation and whether operated in downgraded grades to be entered in the 'remarks' column of the roster/ reservation register.

Sub:- Reservation in promotions- procedure to be followed prior to effecting reservations in the matter of promotions by all departments of the Central Government.

Ministry of Personnel, Public Grievances & Pensions (Deptt. of Personnel & Training) vide ID Note No. 36028/3/2022-Estt(Res.I) dated 21.11.23 has issued certain clarification, in reference to Secretary Directorate's ID Note No ERB-I/2023/14/32(E) dated 07.11.23. The operative part of the said clarification is quoted as under:

"In this regard, it is stated that in Sabharwal judgment, Hon'ble Supreme Court has stated that reserved category candidates can compete for non-reserved post and in the event of appointment to the said post their number cannot be added or taken into consideration for working out the percentage of reservation. The aforesaid instructions were reiterated by the Hon'ble Supreme Court in Jarnail Singh judgment.

"..... However, as stated by the Hon'ble Court, so long as the instructions/Rules providing certain percentage of reservations for the backward classes are operative, the same have to be followed and despite any number of appointment/promotees belonging to the backward classes against the general category posts, the given percentage has to be provided in addition."

"Ministry of Railways is therefore advised to follow the Hon'ble Supreme Court judgements in cases of R K Sabharwal and Jarnail Singh i.e. reserved category candidates can compete for non-reserved post and in the event of their appointment to the said post, their number cannot be added or taken into consideration for working out the percentage of reservation".

The above quoted clarification of DOP&T may please be brought to the notice of all concerned for information and strict compliance.
