





























GOOD WORK DONE BY RPF/ECOR FOR THE PERIOD FROM 01.03.2024 TO 31.03.2024.

1. On 01.03.2024 officers and staff of RPF/Kantabanji and GRPS/ TIG, GROU/Kantabanji apprehended one person viz. Kaviraj Dhandasena, age-45yrs with seizure of 1) Out selling country made liquor about 06 ltrs 800 ML, 2) Beer (alcohol) about 10 ltrs 300 ML, 3) Front line foreign liquor about 02 ltrs 500 ML. Total Value-Rs-5660/- from Railway Premises of Kantabanji. In this connection GRPS/TIG registered a case No-11/2024 U/S 52 (a) Odisha Excise Act against the arrested person. 
2. On 01.03.2024, officer and staff of RPF Post Puri recovered unclaimed ganja weighing about 10.200kgs, valued Rs.90,000/- from circulating area near luggage scanner machine of Puri Railway station. The seized ganja were handed over to GRPS/Puri. On the basis of written report OIC/GRPS/Puri registered a Case vide No-14/2024 dtd 01.03.2024 u/s-20(ii)(b) B NDPS Act.

In this connection Excise Sambalpur registered a case vide crime No. 295/2023 - 2024 U/S 20(b)(ii) (C) of NDPS Act against the accused person. 
4. On 02.03.2024 basis upon a 'PRABAL' data officer and staff of RPF/Post/Visakhapatnam conducted raid and search shop of Annapurna Kirana & general store, Vasantha Rao street, SKML temple road, Visakhapatnam and arrested one tout viz. Adda. Syamala Rao with seizure of 02 nos future tickets valued Rs. 485/- and 55 no's of past tickets value Rs. 90447.25/- total worth Rs. 90932.25 /- with detected 10 nos of personal user IDs with 01 no of IRCTC agent ID. In this connection RPF/Post/Visakhapatnam registered a case vide no. C3C/560/2024 dated 02.03.2024 U/S-143 of the Railways Act. 
5. On 02.03.2024, officer and staff of RPF Post Sambalpur apprehended two persons viz. Shankar Rajbhar, Aged-19 yrs and Sonu Kumar, Aged- 19 yrs with seizure of 20 kgs of Ganja, valued Rs.2,00,000/- from Sambalpur city Railway station. The seized ganja with apprehended persons were handed over to Excise/Sambalpur. In this connection Excise/Sambalpur registered a case vide No. 506/2023-2024 U/S 20(b)(ii)(C) of NDPS Act against them. 
6. On 02.03.2024 officers and staff of RPF/Visakhapatnam and CIB team Waltair apprehended one person viz. Bobbili Maridi Raju, age 31 yrs with seizure of 32 no's Liquor bottles 16 no's Johnnie Walker Black Lable blended scotch whisky bottle each 750ml and 16 no's Jagermeister herbal Liquor cold macerated essence matured in OAK bottle, each 750 ml Total Value-Rs-1,02,400/- from foot over bridge of Visakhapatnam Railway Station. The detained person with seized 32 liquors bottles were handed over to GRPS/VSKP. In this connection GRPS/VSKP registered a case vide No-87/2024, U/S -34(a) of AP excise Act 1968, dated 02.03.2024 against the arrested person. 
7. On 03-03-2024, officers and staff of RPF/Post/Visakhapatnam apprehended 02 theft of passenger belongings offenders with 03 stolen mobile phones valued Rs.12,000/- from Visakhapatnam station. The apprehended person with stolen mobile phones was handed over to GRPS/Visakhapatnam and connected with crime no 81/2024 dt 28.02.2024 U/S 379 IPC of GRPS VSKP 
8. On 03.03.2024, officers & staff of RPF/Post/Bhubaneswar apprehended 02 Ganja peddlers viz. 9. On 03.03.2024, officers & staff of RPF/Post/Palasa seized 36 kgs of unclaimed Ganja valued Rs.1,80,000/- from Palasa station. The seized Ganja was handed over to GRPS/Palasa. In this connection GRPS/Palasa registered a case vide no-56/2024 dt 04.03.2024 U/S-102 CrPC & 8 © NDPS Act-1985 against unknown culprit.

12. On 04/05-03-2024, officers & staff of RPF/Post/Palasa apprehended 01 Ganja peddler viz. Sidhanta Mali, aged-21 years with the seizure of 10 kgs of Ganja valued Rs.50,000/- from Palasa station. The apprehended person with seized Ganja was handed over to GRPS/Palasa where crime no-58/2024 dt 05.03.2024 U/S 8 (c) r/w 20 (b)(ii)(B) NDPS Act 1985 has been registered against the apprehended person. 
13. In the night of 05/06.03.2024 train escort party of RPF/Post/Cuttack rescued a minor girl aged about 15 years with apprehension of one suspected male person viz. Biren Rana, aged 19 years with recovery of cash Rs.22,000/- in T/No.12841 Coromandel Exp. In this connection District/Mobile Unit, BBSR registered a case vide no. 392/23-24, dtd-12.03.2024, U/S 20(b)(ii) C of NDPS Act-1985 against the arrested persons.

24. On 13.03.2024, CIB team/Rayagada along with officers & staff of RPF/Post/Rayagada apprehended 04 female persons viz. i) Pramila Devi,35 yrs, ii) BabiKumari,30 yrs, iii) Harjeet Kour, 27 yrs & iv) Hema with the seizure of 71 kgs of Ganja valued Rs.7,10,000/- from Rayagada station. The seized Ganja with the above 04 female persons were handed over to GRPS/Rayagada where crime no 14/2024 dt 13.03.2024 U/S 20(b) (ii) (c) of NDPS Act 1985 has been registered against them.

27. On 13.03.2024 officer and staff of RPF/Post/VSKP along with GRPS/VSKP apprehended two Ganja peddlers viz.(i) Khativuiddin aged 32 years (ii) Mohad Danish aged 20 years with 08 nos of Absconder accused with the seizure of 155 Kgs of Ganja value Rs.7,75,000/- from PF.No.08 of Vishakhapatnam Railway Station. 33. As per credible information from SIB/Koraput, on 15.03.2024 officer and staff of RPF Post Araku arrested 02 male ganja peddler viz. A1 Mahendar, age-34yrs, A2 Lakshman Kumar, age-53 and 01 female ganja peddler viz. A3 Rajini sharma, age-42 from PF No.01 of Araku Railway station with seizure of 21.43kgs of dry ganja, valued Rs.1,07,155/- from them. In this connection GRPS/VZM registered case No-40/2024 dtd 16.03.2024 U/Sec 8© r/w 20(b)(ii)(c) NDPS Act.
34. On 15.03.2024 officer and staff of RPF Post Koraput along with SIB/Koraput arrested one male ganja peddler viz. Ankit SAhu, age-19yrs from PF No.01 of Koraput Railway station with seizure of 11.06kg ganja valued Rs.1,16,000/-. In this regard GRPS/KRPU registered a vide case No-02/2024 Dtd: 16.03.2024 U/S 20(b) (ii) (B) NDPS act.
35. On 18.03.2024 officer and staff of CIB/SBP along with RPF/Post/SBP and SIB/SBP apprehended one ganja peddler viz. Suraj Kashyap, aged about-21 years, with seizure of 17.3 kgs of ganja valued Rs.1,73,000/- from PF No. 2&3 of Sambalpur Railway station. After conducting all legal formalities the apprehended person along with the seized ganja handed over to GRPs/SBP. In this connection GRPs/SBP registered a case vide No-35 dated 18.03.2024 U/S 20 (b) ii (b) of NDPS Act-1985 against the above accused person.

Dinesh @shankar, age- 27 years with seizure of 8.15 kgs of ganja valued Rs.81,500/- from PF No. 04 of Brahmapur Railway station. D. Satyanarayana, Age-26 years from coach No B-2 of train No. 22504 UP (DBRG-CAPE) Express. The recovered items with the person handed over to GRPS/Palasa. After observing all legal formalities, GRPS/PSA registered a case no. 65/2024 date-18.03.2024 U/S 34(a)(1) of Andhra Pradesh excise Act-1968.
40. On 18.03.2024, PC/RPF/Cuttack received information from IIC Tusura PS of Balangir that, one minor girl kidnapped and travelled by general coach of train No. 12841 Coromandel Express. The same information forwarded to RPF/Post Rajamundry and officer and staff of RPF Rajamundry apprehended the culprit from the above train and handed over to GRPs/Rajmundry. A team of Balangir Police is on the way by road & reaching RJY on 19.03.24 to take kidnapped minor girl & custody of involved culprit from GRPs RJY.

42. On 19.03.2024 officer and staff of RPF/Post/BBS along with GRPS/BBS apprehended one TOPB offender viz. Kalia Sahoo aged 24 years with the seizure of one bag containing wallet cash Rs.2,500/- with 04 nos mobile phone total worth Rs.60,500/-from PF.No.06 of Bhubaneswar Railway Station and handed over to GRPS/BBS. In this connection GRPS/BBS registered a case vide crime No. 47 dt 19.03.2024 U/S 379 IPC
43. The seized Ganja with relevant document was handed over to GRPS/VSKP. In this connection GRPS/VSKP registered a case vide No. 105/2024, dated 19.03.2024 U/s.8(c) r/w 20(b)(ii)(B)and 102 Cr.P.C of N.D.P.S. Act 1985 against unknown.
45. On 20.03.2024 officer and staff of RPF/Post/Titlagarh ,SIB/TIG,CIB/TIG with Excise/Titlagarh apprehended 03 Ganja Peddlers viz. Immediately matter was inform to YM/NCC/VSKP and the said lady with baby was shifted to KGH/Vishakhapatanam through Ambulance and admitted in gynaecologic ward and the on duty doctor stated that the new baby and mother are healthy for further treatment also matter was inform to GRPS/VSKP.
