 The list of permitted commodities for the private siding of M/s. Tata Steel Limited, (Alpha Code – TSLJ & Numerical Code – 12121064) served by Jakhapura station over KUR division was last revised vide Commercial circular No.217(G)/2023 Dtd.31.07.2023 as follows:

Iron Ore, Thermal Coal, Coal, Limestone, Dolomite, Pyroxinite, Quartzite, Olivine/Oli Flux, Iron & Steel Scrap, Iron or Steel Slabs, Iron & Steel Slag and Bentonite Powder and Iron ore rejects.

Outward: Coke, Granulated Pooled Iron/Granshots, Granulated Blast Furnace Slag, Pig iron, Breeze Coke, Iron ore pellets, Sinter, all commodities under Main commodity head Iron or Steel (Group No.12(a) & 12(b) of Goods Tariff No.48 Pt.I Vol.II) and Coal Tar.

2. Now, with the approval of competent authority it has been decided to permit "Iron Pig (Pig Iron)" as inward traffic for the siding. With this inclusion, the revised list of permitted commodities is as follows:

Iron Ore, Thermal Coal, Coal, Limestone, Dolomite, Pyroxinite, Quartzite, Olivine/Oli Flux, Iron & Steel Scrap, Iron or Steel Slabs, Iron & Steel Slag, Bentonite Powder, Iron Ore Rejects and Iron Pig (Pig Iron).

Outward: Coke, Granulated Pooled Iron/Granshots, Granulated Blast Furnace Slag, Pig iron, Breeze Coke, Iron ore pellets, Sinter, all commodities under Main commodity head Iron or Steel (Group No.12(a) and 12(b) of Goods Tariff No.49 Pt.I Vol.II) and Coal Tar.

All other terms and conditions of the circulars under reference shall remain unchanged.
