Sub: Gati Shakti Multi Modal Cargo Terminal of M/s. Container Corporation of India Ltd (CONCOR) served by Paradeep station.

The terminal (Phase-I) of M/s. Container Corporation of India Limited (CONCOR) with Alpha Code - GCCP & Numerical Code - 12121143 served by Paradeep station over KUR Division was notified open as a 'Gati Shakti Multi Modal Cargo Terminal (GCT)' on Through distance basis with chargeable distance as PRDP + 2.53 Km and validity up to 19.10.2024 vide circulars under reference for handling of goods traffic for the following traffic.

- i) Inward Urea.
- ii) Outward Fertilizers, CP coke and Gypsum.

Now, on completion of Phase-II works of GCCP terminal, with the approval of competent authority, the revised chargeable distance for the traffic booked from/ to the GCCP terminal shall be reckoned as PRDP + 2.54 Km.

The revised list of permitted commodities for the Terminal is as follows:

- i) Inward All Commodities (except POL).
- ii) Outward All Commodities (except POL).

Booking and handling of permitted commodities at the GCT will be subject to the guidelines of 'Preferential Traffic Schedule' issued by Ministry of Railways from time to time.

All other terms and conditions notified vide Circulars under reference will remain unchanged.
