



Sub: Haulage Charge on Roundtrip basis for transportation of container traffic
Ref: Rates Master Circular/CRT-CCR-Hub&Spoke/2015/0 and its corrigendum No.30 & 52

Please refer to Corrigendum No.30 dt.06.09.2019 of Rate Master Circular/CRT-CCR-Hub&Spoke/2015/0 stipulating guidelines for round trip based charging in case of ultra short lead(upto 50Kms) container traffic (either EXIM or Domestic or both) which are moving on Haulage Charge per TEU basis. These guidelines alongwith some modification are valid upto 30.04.2024 as per Corrigendum No.52 dt.30.04.2023.

The matter has been examined and it has been decided to extend the currency of above mentioned guidelines beyond 30.04.2024, for a period of one year i.e. upto 30.04.2025.

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Railway Board.


