





1. Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed.
2. General Manager of concerned Zonal Railway has mentioned that the following routes have been upgraded to CC+8 routes for running of freight trains:

North Western Railway	1. Bandikui(BKI)-Dhigawara (DGW)/DN Line
	2. MDJN-PUHT
	3. MVJ-BI
	4. MKN-PBC
	5. BME-MBF

3. Matter has been examined and sanction of the Competent Authority is hereby accorded to include the above mentioned routes of North Western Railway in the list of already identified CC+8 routes.
4. Accordingly, Annexure-III of Rates Master Circular under reference shall be modified.
5. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
6. Operation of CC+8 loads in the aforesaid sections should be allowed after issue of stipulated safety certificates by Zonal Railway.
7. These instructions shall come into effect from 26.04.2024 and shall remain valid till further advice.
8. This issues in consultation with Traffic Transportation, Civil Engineering Directorates and with the concurrence of Finance Directorate of Ministry of Railways.
