

Note:

1. Empanelment of the above candidates is provisional. Employee at Sl. No. 1 is empanelled securing gradation 'OUTSTANDING' maintaining inter-se-seniority after being qualified in the prescribed stages of selection.
2. Total No. of vacancies against 70% selection through special drive for the assessment period 2023-24 is 08 (03-UR, 02-SC & 03-ST) (including one vacancy for PwBD in the category of Hearing Impaired). Three candidates against UR vacancies and one each candidate against SC and ST vacancies are hereby empanelled. As a result, 01-SC and 02-ST vacancies remained unfilled. Since, no PwBD candidate in the category of (Hearing Impaired) is available for promotion, the vacancy is to be carried forwarded in the succeeding recruitment year as per Railway Board's letter No. E(GP)2022/2/20 dated 13.03.2023.
3. The above candidates are found fit in prescribed medical standard for Group 'B' post of AEN and free from SPE/Vig/D&AR cases.
4. Promotion of the above candidates are subject to the condition that they are not undergoing any SPE/Vig/D&AR penalty which adversely affects promotion and subject to availability of vacancy.
5. Promotion of Shri P. Naga Prasad, SSE(PW)/VBL/WAT at Sl. No. 1 above, to Group 'B' post of AEN, will be effected after completion of the undergoing minor penalty.


6. The above promotion is provisional and subject to any further order passed by Hon'ble Supreme Court of India in Civil Appeal No. 629 of 2022 arising out of SLP (C) No. 30621 of 2011.
