Sub: - Selection for the post of Chief Vigilance Inspector (Mech) in Pay Matrix of Level-7 of 7th PC (in Scale Rs.9300 - 34800 in GP of 4600/-of 6th PC) in the Vigilance Department of East Coast Railway, Bhubaneswar.

In order to fill up 01 (One) ex-cadre post of Chief Vigilance Inspector (Mech) in pay Matrix Level-7 of 7th PC (Scale of Rs.9300-34800/- with Grade Pay of Rs.4600/- in 6th P.C) in Vigilance Department of East Coast Railway, Bhubaneswar on deputation basis, it has been decided to hold a selection for forming a panel. The panel will be valid for one year from the date of publication of the panel or till it exhausts, whichever is earlier. The selection consists of a written test and a Vigilance Aptitude & Computer Knowledge Test. The candidates who obtain at least 60% marks in the written examination will be called for appearing in the Vigilance Aptitude & Computer knowledge test.

Eligible candidates may forward their applications through controlling officer in the enclosed proforma only. Candidates may send the advance copy of their application to this office for information. However, applications received through controlling Officers shall only be considered.

Other conditions:

1. The normal establishment rules applicable to the regular selection post are not applicable in this selection of vigilance inspector(Para 821.5 of Indian railway vigilance manual, 2018, as amended from time to time).The applicant should have a flair for vigilance work.Adequate Knowledge of DAR proceeding along with satisfactory professional knowledge is essential.
2. A written test and a vigilance Aptitude and computer Knowledge test will be conducted as part of selection procedure. The distribution of marks for selection is stated below.

3. The syllabus for written test will include questions on knowledge about railway working, writing of report, knowledge about railway service conduct rules and D & AR Rules and departmental Rules and regulations, process, working / functioning, codes and manuals etc.
4. The staff should not have doubtful integrity, should not be figuring in any current vigilance/ SPE/DAR case and should not have been imposed with any major/ minor penalty in any past vigilance case.
5. Staff who has already completed their tenure in the Vigilance Organization earlier as Vigilance Inspector either in Vigilance Branch of Zonal Railway or Vigilance Directorate of Railway Board are eligible subject to after transfer from vigilance unit, a compulsory cooling off period of Three years should be observed,
6. The staff should have completed at least five years service in Railways as on date of notification
7. The post of Chief Vigilance Inspector (Mech) is an Ex Cader post and its tenure will normally be 03 Years (Three Years). However, an inspector can be repatriated on or before completion of the tenure period without assigning any reason whatsoever. The tenure may also be extended as per extant rules.
8. Candidate should preferably be less than 50 years of age. However those above 50 years with atleast 05 years service left (As on Date of the notification).can be considered if found suitable.
9. Computer efficiency is a desirable qualification.
10. Applications in the prescribed proforma must reach this office in a bunch and not in a piece meal manner **on or before 24.05.2024**
11. The notification may be given wide publicity amongst the staff. PCPO/ECOR may please circulate this notification to all eligible staff working in other units / Organisations having lien in Mechanical Engg, Dept. of ECoR.
