











GOOD WORK DONE BY RPF/ECOR FOR THE PERIOD FROM 01.04.2024 TO 30.03.2024.

1. On 02.04.2024, on the basis of PRABAL input CIB/Team Waltair arrested one tout viz. J.Krishna Rao, 28 yrs from Shree Krishna Online Services, VSKP who was involved in illegally procuring and supplying railway reservation e-tickets. In this regard RPF/Post/DVD registered a case under 143 of Railway Act against the tout. 
2. On 01.04.2024 RPF/Sambalpur and GPR/Sambalpur arrested two Ganja peddlers viz. Mansa Devi Female -35 yrs and Gulam Jilani, Male-19 yrs, with the seizure of 45 Kgs of Ganja value Rs.4,50,000/- from PF.No.2 & 3 of Sambalpur Railway Station. In this connection GRPS/SBP registered a case vide No. 44 dtd.02.04.2024 u/s 20(b) (ii) C of NDPS -1985. 
3. On 03.04.2024 on duty staff of RPF/Post/Balangir retrieved a left behind vanity bag containing 01 gold necklace, 01 pair gold ear ring, liquid cash Rs.2500, cosmetic item, one mobile charger and other valuable documents total worth Rs.1,27,500/- at Balangir Railway Station. The retrieved bag with all items was handed over to its rightful owner viz.A Bijaya Laxmi Acharya under proper acknowledgement. 
4. On 04.04.2024, On the basis of PRABAL input, officer and staff of RPF Post VSKP arrested one tout viz. Kommula Bhargav,30 yrs from, Madhurawada, Visakhapatnam who was involved in illegally procuring and supplying railway reservation e-tickets. In this connection RPF Post VSKP registered a U/S 143 of the Railway Act against the tout. 
5. On 04.04.2024, officer and staff of RPF Post Muniguda alongwith Excise/Bisamcuttack and Excise Dist. Mobile Rayagada conducted 03 separate drives arrested 07 ganja peddlers seizure of 61.9 Kgs Ganja Valued of 6,19,000/-. In this connection Excise/District Mobile Unit, Rayagada registered 03 cases under NDPS Act against the arrested persons. 
6. On 04.04.2024, officers & staff of RPF/Post/Puri & GRPS/Puri apprehended 05 male persons Railway premises of Puri Railway station who were making preparation to commit dacoity with recovery of 03 Nos Knife, 10 Nos. branded mobile phones, 05 Chilli powder packets, 01 sketch map, one gas lighter, 02 nos of train tickets, 05 Nos of Mask, Alprazolm Tablet 12 Nos, (Total Value Rs.1,70,231/-). In this regard GRPS/Puri registered a case agsinst them under relevant section of law. 
7. On 06.04.2024, officer & staff of RPF Post/Visakhapatnam seized 02.5 kgs of Ganja valued Rs.12,500/- from PF No.1 near Gate No.03 of Visakhapatnam Railway station as unclaimed. The seized Ganja was handed over to GRPS/Visakhapatnam, who registered a case vide Crime No.126/2024, dtd. 06.04.2024, U/s.8(c) r/w 20(b)(ii)(B) of NDPS Act-1985. 
8. On 07.04.2024 officer & staff of RPF/Post/Rayagada seized 27.550 Kgs of Ganja value Rs,2,75,500/- from PF.No.05 of Rayagada Railway Station. The seized Ganja was handed over to GRPS/Rayagada. In this connection GRPS/Rayagda registered a case under NDPS Act 
9. The arrested persons with seized Ganja was handed over to GRPS/Khurda . In this connection GRPS/KUR registered a case vide crime **No.35/2024, Dtd. 08.04.2024 U/S-20 (b)(ii)(C) NDPS Act.** 

11. On 09.04.2024, officers & staff of RPF/Post/Balangir apprehended one TOPB offender viz. Shankar Pradhan, age-30 Years from Balangir Railway station with a one stolen wallet. The accused person with stolen wallet handed over to GRPS/Balangir. In this regard GRPS/Balangir registered a case vide No.10/2024, dated 09.04.2024, U/S- 379 IPC against the offender.

The arrested person and seized property was connected with RPF/Post KDJR case No. 01/2024 dtd 23.03.2024 U/S 3(a) RP(UP) Act 153 of the R/A.



21. On 15.04.2024, officers & staff of RPF/Koraput and GRPS Koraput seized 08 Kgs Ganja, valued Rs.80,000/- lying unclaimed on PF No.04 & 05 of Koraput Railway Station. In this connection GRPS/Koraput, registered a case vide crime No. 06/2024 Dtd: 15.04.2024 U/S 20(b) (ii) (B) of NDPS Act-1985 against unknown person.

The retrieved bag with all items was handed over to its rightful owner.
