- 1. In terms of Rates Circular No. 20 of 2019, the rates for haulage charges, siding charges, rebooking charges and infringement charges to be collected by different Port Trust Railways were conveyed.
- 2. The request of Mumbai Port Authority for upward revision of charges in the Port has been examined and it has been decided by the Competent Authority to follow the rates as under:-

- 3. The rates of charges for 4-wheeler wagon will be 0.40 times of the rates above of 8-wheeler wagon and will be rounded off to the nearest multiple of rupees five.
- 4. The revised rates shall come into force w.e.f. 10.05.2024 and shall remain applicable till further advice.
- 5. This issues with the concurrence of Finance Directorate of Ministry of Railways.
