Commercial Circular No. 184(G)/2024.

Sub: Commissioning of Gati Shakti Multi-Modal Cargo Terminal (GCT) of M/s UltraTech Cement Limited served by Machapur station.

The terminal of M/s UltraTech Cement Limited with **Alpha Code - UCSM and Numerical Code - 12121156** served by Machapur station (MZY) over Khurda Road division is hereby notified open for handling of goods traffic as a Gati Shakti Multi-Modal Cargo Terminal (GCT). M/s UltraTech Cement Limited will be termed as Gati Shakti Multi-Modal Cargo Terminal Operator (GCTO) of UCSM GCT.

- 1) The chargeable distance for the traffic booked from / to UCSM will be reckoned on Through distance basis as Machapur station (MZY) + 1.96 Km.
- 2) The list of permitted inward & outward commodities for the UCSM GCT is as under:
Inward: All Commodities (except POL).
Outward: All Commodities (except POL).
- 3) Booking and handling of permitted commodities at the GCT will be subject to the guidelines of 'Preferential Traffic Schedule' issued by Ministry of Railways from time to time.
- 4) EOL free time will be applicable at the GCT with Round the Clock working hours.
- 5) The instructions contained in Engine-on-Load Policy (FM Circular No. 16 of 2023 dated 13.12.2023 and amendment from time to time) will be applicable on the GCT.
- 6) Engine Hire Charge (EHC) for detention of Railway Locomotive beyond free time, except on railway account, shall be charged as per Engine-on-Load Policy.
- 7) Traffic of the GCTO M/s UltraTech Cement Limited and authorized rail users permitted by Railway will only be handled in the GCT.
- 8) The GCTO shall be responsible for clearance of all Railway dues, including demurrage charges, accrued within the GCT.
- 9) The UCSM GCT will be governed as per extant GCT policy issued by Railway Board and amendment from time to time.

These instructions will come into force with immediate effect.
