- (2) Eligibility Conditions:
- (A) The following categories of Loco Pilots & Drafted staff who have completed the cooling off period of equal duration having 75,000 KMs of actual driving experience are eligible.

2	Loco Pilot (Passenger)	Pay Matrix Level-06
3	Loco Pilot (Goods)	Pay Matrix Level-06

- **(B)** Medically de-categorised Loco Pilot up to A-3 medical classification who have a minimum of 75000 KMs of actual driving experience are also eligible to volunteer for drafting as CC/DPC/TLC.
- (3) **Tenure**: The tenure of posting of CC/TLC/DPC is three years, i.e., three years with a cooling off period of equal duration. However, this condition will not apply to the medically de-categorised drivers drafted as CC/TLC/DPC.
- (4) Mode of Selection: The eligible optees will be called for to appear in the screening test as per Estt. Srl. No. 38/98 & RBE No. 51/2009. Only the 'Suitable' candidates will be drafted for a period of 3 (three) years to work as CC/TLC/DPC and they shall be governed under all the terms and conditions mentioned in the above Establishment serials.
- (5) Maintenance of Lien & Seniority: The lien and seniority of the candidates selected for the posts of CC/TLC/DPC will be maintained in their respective lien unit/parent cadre from where they have been drafted.
- (6) Pay, Allowance & other conditions: In the eventuality of selection to the post of CC/TLC/DPC, the selected candidates are eligible for payment of allowance in lieu of kilometerage of 120 KMs per day at the rates applicable to them. They are not eligible to claim TA/DA and special pay. They will continue to progress in the running cadre and will be subjected to all the terms & conditions of service as applicable to running staff including pay & allowance, periodical medical examination, selection/suitability tests etc.

- (7) Mode of submission of option application: Willing & eligible staff fulfilling the above conditions may submit their option applications in the prescribed format enclosed in Annexure-A to their controlling office by 30.06.2024. The controlling officer should forward all the applications in a single bunch to this office by 07.07.2024. While filling up the application, the applicant should fill up the actual driving experience at the appropriate place in the enclosed format.
- **(8) Other Conditions:** If any provisions/Railway Board's guidelines is omitted that should be valid and operative.
- **(9)** Administration reserves all rights to cancel or amend the notification partly or wholly at any time without any prior notice or assigning any reasons thereof.

(10) General conditions:

- a) The above stipulation of service condition as Minimum 75000 kms of actual driving experience, in the category of Loco Pilot/Driver will be reckoned as on the date of notification.
- b) This notification should be given wide publicity amongst the eligible Running staff of all crew bases of KUR division and by displaying at conspicuous places.
- c) The eligible staff on leave/ sick/training should also be intimated.
- d) The respective Crew Controller/Supervisor In-charges must thoroughly scrutinize the option applications before forwarding them further.
