

**Sub:** Running of freight trains on CC+8 tonne routes.

**Ref:** (i) Board's letter No.2018/E&R/1(8)/4 dated 24.04.2018.

(ii) Rates Master Circular/PCC/CC+8 etc./2020/0 dated 01.05.2020.

1. Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed.
2. In terms of reference (i) above, General Managers are empowered to approve running of CC+8 operation. Other conditions and procedures remain same.
3. Western Railway has forwarded proposal, with due approval of General Manager, to include the routes **BHRJ - MSIL Pvt. Siding (MSIB) and MSH - VTDI** of Western Railway in the list of already identified CC+8 routes.
4. It is to mention that since BHRJ is a station in the Katosan Road (KTRD) to Bechraji (BHRJ) route notified for 25T route section and MSIB is a siding connected to BHRJ serving station, no separate notification for route connecting serving station and sidings i.e., the BHRJ - MSIB is required.
5. Sanction of the Competent Authority is hereby accorded to include the above referred route **MSH - VTDI** of Western Railway in the list of already identified CC+8 routes subject to maximum permissible speed of 60 kmph. This speed limit can be reviewed by the zonal railway and may be revised as and when required.
6. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified.
7. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
8. These instructions shall come into effect from 25.06.2024 and shall remain valid till further advice.
9. This issues in consultation with Traffic Transportation and with the concurrence of Finance Directorate of Ministry of Railways.
