In continuation of Freight Marketing Circular No. 11 of 2023 dated 30.06.2023, Ministry of Railways has decided to continue the existing haulage charges for movement of Milk traffic for the period from 01.07.2024 to 30.06.2025.

- 2. Accordingly, the Haulage charges for movement of Milk Traffic for the period from 01.07.2024 to 30.06.2025 shall be charged as per Freight Marketing Circular no. 11 of 2023 dated 30.06.2023.
- 3. Haulage charges for new Rail Milk Tankers (VVNH1) shall continue to be calculated by multiplying a factor @ 1.12 times of the applicable Haulage charges, as per FM circular no. 23 of 2019 dated 11.09.2019
- 4. No Charges are to be levied for empty movements of RMTs from unloading points to the loading points for re-loading.
- 5. There shall be no change in other terms and conditions.

This issues with the concurrence of the Finance Directorate of the Ministry of Railways.
