NOTIFICATION

Options are hereby invited from the regular Track Maintainer-IV in level-01 and TM-III in level-2, those who are willing to be inducted on reversion in level-1 for inter departmental transfer against 10% intake to other departments in terms of RBE-138/2023, RBE -146/2018, RBE -121/2013 and Para 179 (XV) of IREM Vol-I.

Eligibility Conditions:-

In terms of Para 179 (XIV) of IREM Vol-I, RBE-121/2013 & 137/2023, the TM-IV in level-1 & TM-III in level-2 who are willing to be transfer on reversion in level-1 irrespective of MACP level of KUR Division should

- 1- Have minimum of 8 years regular service as Trackman.
- 2- Possess physical standards prescribed for recruitment to that department.
- 3- Have aptitude for work to which the candidates are to be transferred.
- 4- Be 38 years and above age as on the date of notification i.e. the applicant should have been born on 04.07.1986 or before.
- 5- Be literate.
- 6- Medical fitness as required for the concerned post to which transfer sought.

Selection criteria:- Applications of Track Maintainers of KUR division those who fulfill all the eligibility conditions will be shortlisted on the basis of inter-se seniority based on the length of the service rendered as Trackman and the suitable candidates will be considered after screening. The DOB will determine the seniority of the applicant while seniority of two or more candidates will be the same, i.e. older employee will be considered. On successful completion of screening, a panel of suitable candidates will be formed based on the inter-se seniority and preference exercised by the applicant.

Seniority:- The seniority of TM transferred to different Department by virtue of 10% intake will be fixed taking half of the length of continuous service of TM in the new cadre to which he/she will be absorbed.

Procedure for receipt, scrutiny and forwarding of application:-

The regular TM-IV in level-1 and TM-III in level-2 willing to be transferred on reversion in level-1 (irrespective of MACP level) of KUR Division who full fills the terms and conditions of eligibility as stated above may exercise option for transfer to other department duly filling all the particulars in the enclosed format and submit the same to the concerned supervisor.

The supervisor or unit-in-charges are advised to forward the valid applications in order of seniority based on the length of service checking the data as per Service Record to Sr.DEN(Co-ord) through concerned ADEN.

Sr.DEN(Co-ord) is requested to submit the applications with a consolidated statement containing all the data of all columns of the application as well as soft copy in Excel sheet to this office via email ID - pnandy79@gmail.com.
