MEMORANDUM

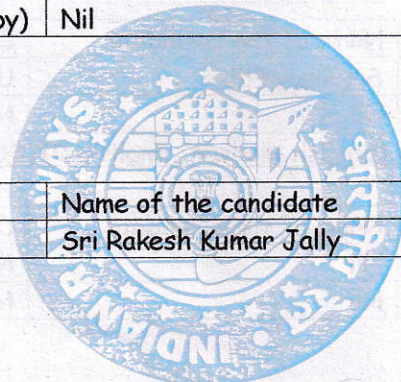


