**Commercial Circular No. 247(G)/2024**

Sub: Change of Maintenance depot for 07 rakes of M/s T M International Logistics Ltd inducted under GPWIS.

1. M/s T M International Logistics Ltd has so far inducted 28 BOXNHL / BOXNHL25T rakes under GPWIS over this Railway.
2. Now, Railway Board vide letter No. 2018/TC(FM)/4/25 dated 28.06.2024 has approved for change in maintenance depot for 07 rakes out of these 28 rakes.
3. The 07 rakes for which Railway Board has approved for change of maintenance depot were notified vide Commercial Circulars mentioned in the table below:

5. Further, in case of the 24<sup>th</sup>, 26<sup>th</sup>, 27<sup>th</sup> & 28<sup>th</sup> rakes of the Party, in addition to Adityapur (ADTP) of South Eastern Railway, **Bondamunda (BNDM)** will be the maintenance depot "for the additional circuit – 2" of the initial commercial notification as mentioned above.

All other terms and conditions mentioned in the notification(s) for these rakes will remain unchanged.
