Sub: Freight incentive for loading of fly ash in GPWIS rake.- clarification regarding

As per extant rules, 10% rebate is granted on freight in case of loading by parties in their GPWIS rakes. The rebate is also granted to the GPWIS rake owners in case the rake is used by IR for its own loading i.e. against general indent.

2. A question has arisen regarding grant of other concessions concurrently with rebate in case of GPWIS rakes. One zonal railway has stated that freight incentive of 20% of NTR is not being granted for Fly Ash when loaded by IR in empty direction in GPWIS rake against general indent. Some GPWIS customers have also represented that the fly-ash discount is not being granted when fly-ash is loaded in their GPWIS rakes.

3. The above matter has been examined in consultation with TT, Rates and Finance Directorates in Railway Board. Accordingly, it is clarified that:-

(i) Unless specifically mentioned, no concession/discount except the 10% freight rebate shall be given to GPWIS investor till the recovery of investment by such GPWIS rake investors.

(ii) Fly-ash concession (or any other concession) as admissible on IR rake shall be made available to non-GPWIS customers who are allotted GPWIS rakes against general IR indents.

(iii) Efforts should be made to supply rakes as per the indent placed by customers i.e. IR rake to be provided in case of general indent.

4. Zonal Railways may take necessary action accordingly. FOIS/CRIS is requested to ensure that the system is updated on the above lines
