Their pay & allowances will be regulated in terms of instructions allowances will be regulated by the Ministry of Railways from time to time. They will also be entitled to the other facilities in the same manner as are admissible to other similarly placed employees working in Level-1 of the CPC Pay Matrix, in Railway Board.

X	Preparation & Duration Panel	earlier. No extension in any condition will be permissible. A panel will be prepared from amongst the eligible applicants who apply against the vacancies circulated, by way of conducting a selection by the duly notified Selection Committee for the purpose. The vacancies to be taken into account shall include existing vacancies plus normal future requirements for next 18 months. Once the recommendations of the Selection Committee are accepted by the Competent Authority, the same will be notified on the Notice Board of Railway Board. The validity of the panel will be two years from the date of publication of the panel. Based on the above panel, candidates borne on the panel will be offered appointment as Sainiks on deputation basis, in the order of their panel position, till panel is exhausted/or till validity of the panel, whichever is earlier. Action for preparation of new panel may be initiated every year in the month of January.
