- 1. Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed.
- 2. In terms of reference (i) above, General Manager are empowered to approve running of CC+8 operation. Other conditions and procedures remain same.
- 3. South Western Railway has forwarded proposal with due approval of General Manager to include routes in the list of already identified CC+8 routes as below:
 - i. Ginigera (GIN) Gangavathi (GGVT)
 - ii. Bagalkot (BGK) Khajjidoni (KJDI)
 - iii. Penukonda (PKD)- Dharmavaram (DMM) via SSPN
- 4. South Western Railway has also requested for CC+8 notification for routes from serving stations to their sidings. It is clarified that since the serving stations are already notified in CC+8 routes, no separate notification will be issued for route connecting serving stations and sidings.
- 5. Sanction of the Competent Authority is hereby accorded to include the above referred routes of South Western Railway in the list of already identified CC+8 routes subject to a maximum permissible speed as decided by the Zonal Railways.
- 6. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified.
- 7. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
- 8. These instructions shall come into effect from 31.07.2024 and shall remain valid till further advice.
