**Sub:** Transportation and charging of 'Track Machine' owned by other than Indian Railways.

**Ref:** Rates Circular No. 11 of 2023 and corrigenda thereto.

1.0 Reference above, the rates for transportation and speed trial of Track Machine have been notified. The matter has been reviewed and the Competent Authority has decided to revise the rates as under:

2.0 Charging of 'Track Machine' owned by other than Indian Railways will be for transporting the same, from the siding of Track Machine Manufacturer/ Indian Railways to the required place and vice-versa or any other movement over Indian Railways as under:

Type of Track Machine	Charges
Self-propelled and are required to be carried without attachment of engine *	₹ 270 per Track Machine per km. subject to a minimum of ₹ 27,000/- per Track Machine.
Non-self-propelled, and are required to be carried with attachment of engine *	₹ 515 per Track Machine per km. subject to a minimum of ₹ 51,500/- per Track Machine.
Track Machine which runs as a trainset in haulage like RGM, TRT etc.	₹3,720/- per km. subject to a minimum of ₹3,72,000/-.
* The speed trial of these track machines shall be charged @ charges mentioned against them.	

3.0 All other details of Rates Circular No. 11 of 2023 and corrigenda thereto shall remain the same.

4.0 This shall come into force from 20.08.2024 and shall remain valid till 31.03.2025.

5.0 This issues with the concurrence of Finance Directorate of Ministry of Railways.
