NOTIFICATION

Sub: Re-engagement of Retired Railway Employees in exigencies of Service for the post of Radiographer in Medical Department of DRH/SBP/ECoR.

Ref: RBE No.150/2017 & RBE No. 193/2017 & RBE No. 59/2024.

Applications in the prescribed Proforma(Annexure-A) along with required enclosure, are invited from the Chief Radiographer/Radiographer retired from Indian Railway for filling up of 01 (One) post of Radiographer, Level-5 for re-engagement in DRH/Sambalpur Division for a period up to 30.06.2025 or the date of attaining the age 65 years subject to extension of validity of the scheme beyond 30.06.2025 by Railway Board or till the vacancy is filled up through regular selected candidates whichever is earlier.

- 1. **REMUNERATION**: Monthly remuneration for retired employees being re-engaged will be determined by reducing Pension from his/her last pay drawn(i.e. Basic Pay + DA -Pension).
- 2. MODE OF SELECTION: Suitability/Competency of the retired railway employees will be adjudged by a viva-voce and examination of Service Records.
- 3. OTHER TERMS AND CONDITIONS FOR THE RE-ENGAGEMENT OF RETIRED STAFF ARE AS FOLLOWS:
 - i. The duty hours of the Re-engaged Retired Employees would be as prescribed by the Competent Authority as per exigency of service.
 - ii. The rest/weekly off may be on different days not necessarily on holidays, etc.
 - iii. The selected retired railway employees will be subjected to medical examination of appropriate category as per extant railway rules and only those who are found fit in the prescribed medical examination will be re-engaged.
 - iv. In case of unsatisfactory work or misconduct on the part of the retired employees so reengaged, Railway reserves the right to terminate the service at any time without assigning any reasons thereof.
 - v. The Railway Employees retired under Safety Related Retirement Scheme(SRRS)/Liberalised Active Retirement Scheme for Guaranteed Employment for Safety Staff(LARSGESS) are not eligible for re-engagement.
 - vi. The employees Removed/Dismissed/Compulsory Retired as a result of disciplinary action or in review are also not eligible for re-engagement.
- vii. The retired employees on their re-engagement will be governed by the instructions issued by the Railway Ministry/Railway Administration.
- viii. The East Coast Railway Administration reserves the right to deploy the retired employees in any area depending upon the exigency of the service and refusal or otherwise will be treated as misconduct on the part of the candidates.
- ix. The selected retired railway employees will be paid the remuneration as noted in para-2(Serial No. 1) mentioned above and cannot claim any additional remuneration, allowances or other benefits during the stipulated period.
- x. The retired railway employees are personally responsible for payment of professional tax, income tax and other duties/taxes levied by the State/Central Governments.
- xi. The Railway Administration reserves the right to cancel, amend or otherwise modify all or any of the terms of this notification without assigning any reason(s) thereto.

- 5. HOW TO APPLY: Eligible & interested Retired employees are advised to send their applications in prescribed format along with self attested Photostats copies of the relevant documents addressed to Principal Chief Personnel Officer, East Coast Railway, Rail Sadan, 2nd Floor, South Block, C.S. Pur, Bhubaneswar-751017 superscribing on the top of the envelope "Application form for re-engagement of retired employee for Radiographer." on or before 26-09-2024 and the date of viva-voce test will be intimated over telephone or letter for attending the viva-voce test accordingly.
- 6. Retired employees are hereby requested to read the terms and conditions in detail as above.

NB: No TA/DA/Accommodation will be provided to the retired railway employees for attending the viva-voce Test.
