With the approval of the General Manager/East Coast Railway, the following orders are issued.

- NB: (i) The provisional panel of Shri Athey Prakasa Rao, SSE(Genl)/WAT for promotion to the post of AEE in Group-B/Electrical service has been approved by the General Manager /E.Co.Railway on 02.05.2024 and is in terms of PCPO/ECoR's Memorandum No. ECoR/Pers/Gaz/Gr.B/Electrical/AEE-70%/Panel/SPL-2023 dated 03.05.2024. He is found medically fit in prescribed medical standard and free from SPE/Vig/D&AR cases.
 - (ii) The promotion of Shri Athey Prakasa Rao is provisional and subject to any further order passed by Hon'ble Supreme Court of Indiain Civil AppealNo. 629 of 2022 arising out of SLP(C) No. 30621 of 2011
 - (iii) Attention to the above officer at Srl. No. 1 should be drawn to the availability of option for fixation of pay as per Railway Board's instructions issued from time to time, so that he is fully aware of this while accepting the promotion.
 - (iv) Shri N.Kishore Kumar has reported to this Railway on 29.04.2024. Hence the period from 29.04.2024 to 14.05.2024 excluding leave if any will be treated as "waiting for orders" in his favour
