With the approval of the General Manager/East Coast Railway, the following orders are issued.

NB: The provisional panel of above Group- C staff at Srl. No. 3 for promotion to the post of AMM in Group-B/Store department has been approved by the General Manager/E.Co.Railway on 25.04.2024 and is in terms of PCPO/ECOR's Memorandum No. ECoR/Pers/Gaz/Gr.B/Store/AMM-70%/Panel/SPL-2023 dated 26.04.2024. He is found medically fit in prescribed medical standard and free from SPE/Vig/D&AR cases.

(ii) The above promotion is provisional and subject to any further order passed by Hon'ble Supreme Court of India in Civil Appeal No. 629 of 2022 arising out of SLP(C) No. 30621 of 2011.

(ii) Attention to the above officer at Srl No. 3 should be drawn to the availability of option for fixation of pay as per Railway Board's instructions issued from time to time, so that he is fully aware of this while accepting the promotion.
