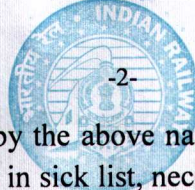

The candidature of the above named candidates appearing in the viva-voce test has been accepted provisionally. If any candidate is subsequently found ineligible at any stage of the selection, his name will be deleted without further notice.


