- 2.0 Para no. 14(C) of Private Siding standard Agreement given under Annexure-3 of FMC 11 of 2016 regarding 'handling of such commodities in siding, which are not related or requirement of the industry of the siding', has been reviewed and has been amended as under -

Existing para	Revised Para
Para 14(C) of Annexure 3 : No traffic in commodities other than such as can reasonably be regarded as necessary for the working or requirement of the mill, factory, or industry of the firm, shall, except with the written permission of the General Manager of the _____ Railway or an Officer authorized by him, be at any time taken or sent by the Applicant over the siding. No consideration or remuneration of any nature, except such as may be contained in a written permission of the General Manager or an Officer authorized by him, shall be received or taken by the Applicant in respect of traffic over the siding.	Para 14(C) of Annexure 3 : Any additional commodities other than the commodities initially approved for handling on a private siding, if requested by private siding owner on their private sidings shall be approved by General Manager of the _____ Railway or an Officer authorized by him, subject to the compliance of State and Central regulations w.r.t. additional commodity proposed. Necessary Infrastructure (if required) for this purpose shall be provided by siding owner at his own cost and Zonal Railway must ensure such provision before notification of additional commodities.

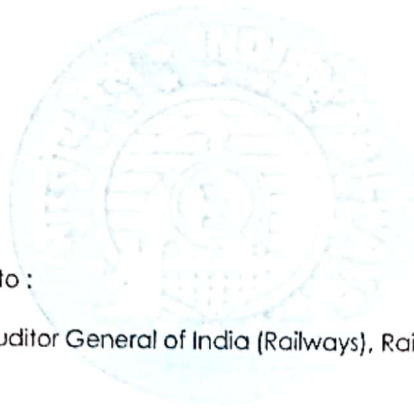
