

1. Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes is prescribed.
2. In terms of reference (i) above, General Managers are empowered to approve running of CC+8 operation. Other conditions and procedures remain same.
3. South East Central Railway has forwarded proposal with due approval of General Manager to include route in the list of already identified CC+8 routes as below:

Balaghat (BTC)-Katangi (KGE)-Tirodi (TRDI)

4. Sanction of the Competent Authority is hereby accorded to include the above referred route of South East Central Railway in the list of already identified CC+8 routes subject to maximum permissible speed of 60 kmph for the 1042.885 to 1089.655 except Main line at km 1054/06-1054/13(380m Kaydi PH)) & 1060/10-1060/0(525m in WRI Yard) at speed restriction of 45 Kmph. This limit shall be reviewed by the Zonal Railway and may be revised as and when required.
5. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified.
6. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
7. These instructions shall come into effect from 07.09.2024 and shall remain valid till further advice.
8. This issues in consultation with Traffic Transportation and with the concurrence of Finance Directorate of Ministry of Railways.


