**Sub**:-Modification against notification dated: 23.07.2024, for Filling up of vacancies of Assistant Loco Pilot(Electrical)in pay matrix Level-2 against 50% Departmental Quota on one time measure as per eligibility norms of GDCE quota in terms of RBE No.-32/2024 of Khurda Road Division.

As per the provision laid down in RBE No-32/2024, to fill up of 221 vacancies of ALP in Level-2against 50% Departmental quota in Electrical(OP)/Rg. Department, have been notified vide No. P/Staff/Elect(OP)/Rng/ALP/DPQ/2024 Dated: 23.07.2024.

In terms of clarification received from Railway Board vide Lt No-E(NG)/2024/PM1/06 dated:30.07.2024, the following modifications/amendments are hereby notified in the Notification No. P/Staff/Elect(OP)/Rng/ALP/DPQ/2024 Dtd:23.07.24.

6	Mode of selection	Selection procedure will include Written Test (OMR based)having one part, followed by Aptitude Test (OMR based) in which candidates who have passed in the Written Examination would be called. Those who qualify in the Aptitude Test, would be subjected toMedical examination for fitness in A-1 Medical category. Candidates, who qualify in written test &Aptitude test and found fit in in A-1 medical category, will be considered for provisional empanelment subject to Scrutiny of SR/APAR for last three years i.e. 2021-22, 2022-23, 2023-24and DAR/Vigilance clearance. Aptitude test is only Qualifying in nature.
7		As per existing instruction issued by RBE-196/2018 & RBE-97/2019, the mode of written test will be as follows:  (i) The written examination is to be conducted on OMR Sheet. Correct answers are to be marked by the candidates on OMR answer sheets. The duration of the written examination will be 120 minutes(Two hours).  (ii) The question paper will be 100% objective type with multiple-choice types with four answer options in the sequence A,B,C&D.All objective type questions will carry equal marks.  (iii) There will be 110 questions including 10 questions (optional) on Rajbhasha Policy. The candidate has to answer a maximum of 100 questions. In case, the candidate answers more than 100 questions, first 100 attempted questions are to be taken for evaluation.  (iv) Cutting, overwriting, erasing or alteration of any type in the answer is not allowed. Zero mark will be awarded for Answer having correction/overwriting.

(v) It is being a general selection; there is provision of negative marking for wrong/incorrect answer and 1/3<sup>rd</sup> marks will be deducted for each wrong answer in terms of RBE No.-194/2019. (vi) Pass Mark in Written Test is 60 and final panel will be prepared from amongst those who secure minimum of 60% marks in professional ability (written test) and 60% in aggregate according to the vacancies notified above on the basis of merit. There will be no relaxation in marks for SC/ST candidates, since it is a Safety category post. (vii) Weightage of Written Test and Record of Service would be 85 and 15 respectively. (viii) The syllabus shall be as below: a. Mathematics: Number system, BODMAS, Decimals, Fractions, LCM, HCF, Ratio and Proportion, Percentages, Mensuration, Time and Work; Time and Distance, Simple and Compound Interest, Profit and Loss, Algebra, Geometry and Trigonometry, Elementary Statistics, Square Root, Age Calculations, Calendar & Clock, Pipes & Cistern etc. b.General Intelligence and Reasoning: Analogies, Alphabetical and Number Series, Coding and Decoding, Mathematical operations, Syllogism, Jumbling, Venn Relationships, Diagram, Interpretation and Sufficiency, Conclusions and decision making, Similarities and differences, Analytical reasoning, Classification, Directions, Statement – Arguments and Assumptions etc. c. Basic Science and Engineering: The broad topics that are covered under this shall be Engineering Drawing (Projections, Views, Drawing Instruments, Lines, Geometric figures, Symbolic Representation), Units, Measurements, Mass Weight and Density, Work Power and Energy, Speed and Velocity, Heat and Temperature, Basic Electricity, Levers and Simple Machines, Occupational Safety and Health, Environment Education, IT Literacy etc. d.General Awareness on Current Affairs in Science & Technology, Sports, Culture, Personalities, Economics, Politics and any other subjects of importance. e. Knowledge on Rajbhasha. (ix) Pre-selection Coaching: -The pre-selection coaching for the reserved community candidates is to be imparted for 03 to 04 weeks covering the syllabus of the examination for the selection to the safety category post. After pre-selection coaching, a certificate is to be issued by the controlling officer to this effect that, all such candidates have been imparted preselection coaching. In case, if any candidate expressed his unwillingness for pre-selection coaching a written declaration to that effect may be obtained from the candidate and forwarded to this office for record Normalization of Omitted. 8 the marks for Part-A & Part B Computer based Aptitude test will be conducted on OMR based, for which aptitude test for candidates qualifying on the written test will be called. ALP (CBAT) (i) In view of the Modification in the modalities of selection, the last Last date for

date of submission of application is extended upto 03.10.2024 as submission of 11 application detailed below. The applicants who have already submitted notification application against the P/Staff/Elect(OP)/Rng/ALP/DPQ/2024 Dated: 23.07.2024, need not apply again. (ii) The willing and eligible employees have to submit their application in prescribed proforma to their controlling supervisors on or before 03.10.2024 who will forward the application in one bunch to the controlling officers on or before 07.10.2024. The controlling office has to forward all the application in one bunch to this office together on or before <u>09.10.2024</u>. Application received after the last date will summarily be rejected without assigning any reason. (iii) It may be noted that all the relevant columns in the application should be filled in completely & strike out the inapplicable columns indicating as "NA" and forward duly verified & certified the controlling supervisors/officers wherever specified in the application or otherwise same will not be considered. (iv)The application received beyond the last date should not be entertained and rejected invariably by the controlling supervisors/ officers and same will not be considered.

The decision of the question Setter in publishing the Final Answer Key after disposal of representations, if any, submitted by the written appeared candidates within the stipulated period will be final and no further correspondence in this regard will be entertained.
- (4) **Date and Venue of Examination**: Candidates are advised to be in readiness to appear in the forthcoming written examination at short notice. The exact date, time & venue of written examination will be intimated in due course.
