3. BCACBM rakes are to be run on above routes with condition as stipulated in CRS/GM sanction and letter of respective Zonal Railways.
4. Freight shall be charged as per extant rules.
5. Zonal Railways are advised to ensure that the rakes are not run overdue for examination or maintenance.
6. This has the approval of Traffic Transportation Directorate of Ministry of Railways.
