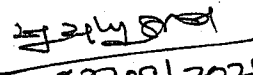

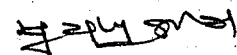

**Sub: Corrigendum No. 4 to 'Final Modalities' issued vide No.2024/SBEC-III/ Elections dated 09.09.2024 for Secret Ballot Elections-III.**

In terms of provisions of Section 22 of Final Modalities, the SBEC has approved the following modifications in the 'Final Modalities':

**I.** The last sentence of Section 17.0 on 'Storage and Security of Ballot Boxes' is modified to be read as under:

“At the end of the Polling, these Ballot Boxes should be transported to the Counting Centres, as identified and notified by the Returning Officer and reiterated by Presiding Officer, under proper security.”

**II.** Furthermore, a new sentence as follows should be added beneath the above sentence in Section 17.0:

“CCTV coverage shall be provided at (i) all the strong room/storage points where Ballot Boxes are identified to be stored both before (one day in advance) and after the polling and (ii) all Counting Centres where counting of votes is to be done.”

**III.** Therefore, incorporating the aforementioned modification/addition, the new modified Section 17.0 should be read as under:

**“17.0 Storage and Security of Ballot Boxes:** After the polling is held on a day, the Ballot Boxes should be duly sealed by obtaining the signature of Polling Officer, Polling Agents of TUs present and designated Security in-charge. Thereafter, it should be stored in a strong room, which should have been already notified to the contesting unions. At the end of every day of polling, the boxes are required to be kept in the strong room and sealed. The sealing of the strong room should be done after obtaining the signatures of the designated (by PO) functionary, RPF/RPSF Staff and Polling Agents (designated by TUs for this purpose). At the end of the Polling, these Ballot Boxes should be transported to the Counting Centres, as identified and notified by the Returning Officer and reiterated by Presiding Officer, under proper security. CCTV coverage shall be provided at (i) all the strong room/storage points where Ballot Boxes are identified to be stored both before (one day in advance) and after the polling and (ii) all Counting Centres where counting of votes is to be done.”
