<u>Sub.</u> 'Secret Ballot Election' (SBE) for Verification of Trade Unions on Indian Railways.

Vide letters referred above, NWR & WCR have raised some queries related to Secret Ballot Elections, 2024. The point-wise reply/clarification to the queries are as under:

A) NWR:

i. Allotment of Election Symbols: Some of the TUs have raised a concern that it will be difficult to campaign without a fixed election symbol and have requested for early decision on symbol allotment.

<u>Reply/Clarification</u>: It is not possible to allot Election Symbols till applicant TU's eligibility to contest is established.

ii. An exclusive Presiding Officer or Assistant Presiding Officer or Polling Officer should be nominated separately for monitoring the entire exercise of 'Postal Ballot Papers'.

<u>Reply/Clarification</u>: A JAG/SG Officer of Headquarter may be identified as 'Postal Ballot Officer' to assist RO in these matters.

iii. Some of the TUs have raised a concern that TU Registrar office does not provide acknowledged copy of the 'Return' due to online submission of return.

Reply/Clarification: For on-line submission of Return, there must be an acknowledgement or Transaction ID or confirmation over mail/SMS. Any such evidence can be attached in lieu of "Return acknowledged by Registrar".

iv Deputation of Railway Staff to the recognized Unions/Federations as full-time workers-

Reply/Clarification: The Railway Servants on deputation to TUs are paid by the concerned Trade Union. Therefore, status quo (as on 30.08.2024) regarding them should be maintained till conclusion of elections process.

B) WCR

West Central Railway has sought clarification whether deduction of subscription and *Chanda* (i.e. Donation) in favour of TU from Salary/PLB is to be made or not?

Reply/Clarification: The recognized Trade Unions are treated as recognized till new Trade Union is given recognition. Collection of subscription (through Salary/PLB) is a natural corollary of recognition. Hence, Railways/PUs may continue to deduct monthly/annual subscription from the Salary/PLB on behalf of recognized Trade Union as per extant practice. However, no other deduction such as donation should be made on behalf of Trade Union till the conclusion of election process.
