Ref.: Rates Master Circular on Block Rakes/Mini Rake/Two Point Combination etc./2020 and its Corrigenda - No.37 dated 26.09.2022 & its correction slip dated 27.09.2022 and Corrigendum no.48 dated 29.09.2023.

1. Reference above, two point destination rake product was notified for loading of Anhydrous Denatured Ethanol (meant for blending with fossil fuels) from any point/terminal of Indian Railways to Guwahati/ Digboi subject to laid down terms and condition for two point rake in other than covered wagons. This product is valid up to 30.09.2024.
2. The matter has been reviewed and the Competent Authority has now decided to permit two point rake in other than covered wagons for loading of Anhydrous Denatured Ethanol (meant for blending with fossil fuels) as under:
