### **Commercial Circular No. 351(G)/2024**

**Sub:** Change of Maintenance depot for 10 rakes of M/s T M International Logistics Ltd inducted under GPWIS.

1. M/s T M International Logistics Ltd has so far inducted 28 BOXNHL / BOXNHL25T rakes under GPWIS over this Railway.

3. The 10 rakes for which Railway Board has approved for change of maintenance depot were initially notified vide Commercial Circulars mentioned in the table below:


