## Commercial Circular No. 364(G)/2024

<u>Sub</u>: Conversion of 57 BOXNHL wagons inducted by M/s T M International Logistics Limited under GPWIS into BOXNHL25T wagons.

- The 26<sup>th</sup> BOXNHL rakes of M/s T M International Logistics Limited (Agreement ID in FOIS – TMITECO220320241133) was initially notified under GPWIS vide PCCM/ECoR's Commercial circular No. 114(G)/2024 dated 22.03.2024.
- 2) Railway Board vide letter No.2018/TC(FM)/4/06 dtd.12.03.2021 have issued instructions that BOXNHL wagons procured under GPWIS would be converted into BOXNHL25T wagons.
- Accordingly, some BOXNHL wagons of the above mentioned rake (26th) have been converted into BOXNHL25T wagons at maintenance depot at Adityapur (ADTP) of South Eastern Railway.
