**Northern Railway Rates Opening/Closing Circular No. 16 of 2024
Case No 1329-R/O&C/2024)**

Sub:- Restriction on booking and handling of parcel traffic at NDLS, DLI and ANVT stations in view of Deepawali & Chhath Rush arrangements.

In view of the security arrangement during upcoming festival rush i.e. Deepawali & Chhath, it has been decided by Delhi division to impose restrictions **on all types of Parcel handling activities** (including handling of leased SLRs, VPs & advance/demand VPs) in Delhi area (i.e. NDLS, DLI & ANVT stations) from **30/10/2024 to 06/11/2024** to ensure safety of passengers and to avoid any untoward incident in platform/station area during festivals of Deepawali & Chhath Pooja.

However, booking of departmental parcels will be restricted from **28/10/2024 to 06/11/2024** at NDLS, DLI & ANVT stations.

Moreover, at ANVT station, there will be no restriction on handling of leased space from washing line & stabling line. These restrictions will be applicable only for leased space handled at platforms. Similarly there will be no restriction on handling of leased VPs, Demand VPs/Advance VPs at Central Cargo Complex (CCC)/NDLS. These restriction will be applicable only for leased space handled at platforms at these stations.

Parcel restrictions will be applicable on leased SLRs and VPs (including Advance/Demand VPs) of the trains originating from Delhi area stations i.e. NDLS, DLI & ANVT and also applicable on passing trains originating from other division/zones and having stoppage for loading & unloading at these stations.


It is clarified that the personal luggage may be allowed in the passenger coaches only and booking of registered newspapers and magazines shall be permitted after observing all commercial formalities etc.

Therefore, keeping in view the above facts and security concerns during forthcoming Deepawali & Chhath festival celebrations, restriction is imposed for handling of all types of parcel transactions (handling leased SLRs, VPs including Advance/Demand VPs) in Delhi area i.e. (NDLS, DLI & ANVT stations) from **30/10/2024 to 06/11/2024** and (restriction on departmental booking from **28.10.2024 to 06.11.2024**).

The stacking of parcels at platforms and cross movement of the trolleys from one end of the platform to another end may also be prohibited.

All concerned may be advised for strict compliance accordingly.
