<u>Sub</u>: Restriction on booking and handling of parcel traffic Over Central Railway due to heavy rush on account of Diwali and Chhat Pooja festivals.

In view of heavy rush during festive season and to maintain punctuality position, it has been decided to impose restriction on handling of all kinds <u>parcel activities(including leased SLRs, VPs and advance/indent VPs)</u> for <u>Pune</u> station of Mumbai division of Central Railway from <u>28.10.2024 to 06.11.2024</u> to ensure safety of passenger and to avoid any untoward incident at Platform/Station area during the festive season of Diwali and Chhat Pooja.
