Sub: -Procedure for dealing with wagons under Own Your Wagon Scheme (OYWS) that completed 20 years of service.

Ref:- FM Circular No. 25 of 2024 issued vide Board's letter of even number dated 07.10.2024.

In terms of Para (iii) of FM Circular under reference, it is communicated that **BOXN** and **BCNA** wagons inducted under OYWS may be returned to the investors. As for **BOY**, **BCCW**, **BOBRN**, **BTPN** and **BTPGL** wagons, Railway may consider extending the agreement for tertiary period (beyond 20 years) in consultation with the party.

- 2. It is also clarified that scrap value mentioned in Para (iv) of Board's letter under reference shall be paid after deducting departmental charges @ 12.5% of the total sale value as per extant codal provisions.
- 3. This issues in consultation with Traffic Transportation, Store and Finance Directorate of Ministry of Railways.
