**Sub: Clarification on Section 1.4.1 of Modalities for Secret Ballot Election – 2024 - reg.**

Section 1.4.1 of Final Modalities for Secret Ballot Elections issued on 09.09.2024 states that:

*"In view of an interim order dated 13.02.2020 passed by High Court of Judicature at Bombay, Nagpur Bench in Writ Petition No. 29/2020 ('Swatantra Railway Bahujan Karmachari Union Vs. Government of India, Ministry of Railways'), those registered Trade Unions with all-India jurisdiction and having the jurisdiction over the concerned Zonal Railways/PUs shall also be eligible to contest the election subject to the decision of above Court Case. Further instructions will be issued on this matter separately."*

2. In compliance with Section 1.4.1 of Final Modalities dated 09.09.2024, SBEC had issued letter No.2024/SBEC-III/Elections dated 21.10.2024 which was subsequently withdrawn vide letter No.2024/SBEC-III/Elections dated 23.10.2024 as it was felt that further consultation with railway administration was required.

3. The matter has been examined in Board's office and it has been decided that the required clarification may be issued after declaration of results of the Secret Ballot Elections 2024.
