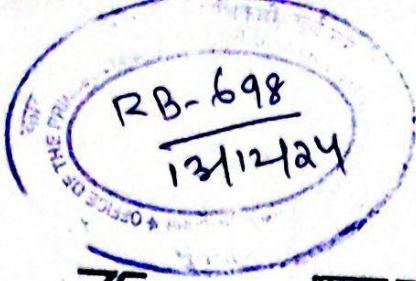

Sub: Reimbursement of Children education Allowance to Railway employees whose wards are studying in non-recognized schools/institutions.

Ref.: ECoR's letter No. ECoR/Pers /Bills (NG)/CEA/Clarification dated 27-11-2024.

With reference to Railway's above cited letter, attention is invited to Para 2(q) of DoP&T's OM No. A27012/02/2017-Estt.(AL) dated 17-07-2018 in terms of which reimbursement of Children Education Allowance (CEA) for pre-schools is permissible only if the ward of Railway servant is studying in a recognized school/institution, except in case of Divyang child. Recognized school/institution in this regard means a Government School or any education institution whether in receipt of Government Aid or not, recognized by the Central or State Government or Union Territory Administration or by University or a recognized educational authority having jurisdiction over the area where the institution/school is situated.

2. Since Ministry of Railways have adopted DoP&T's aforesaid Office Memorandum mutatis-mutandis basis, vide Master Circular No. 17 dated 22-08-2019, it is not feasible to take any unilateral view in this matter. The Railway is, accordingly, advised to follow the extant instructions.
