
**Sub: Additional free time for covering wagons with tarpaulins during loading of loose/bulk commodities**

**Ref: Corrigendum No.14 to Rates Master Circular/Demurrage-Wharfage-Waiver/2016/0 dt.21.10.2020**

Please refer to Board's Circular under reference which stipulates as under-

*"Additional free time of one hour per rake may be permitted for covering open wagons with tarpaulins during loading of loose/bulk commodity (e.g. Coal & Coke etc. for which packing condition P2(a) is prescribed in the Goods Tariff) at all kinds of freight terminals e.g. goods sheds, sidings (including EOL sidings), PFTs etc.*

In the above guidelines, "open wagons" means top open wagons e.g. BOXN, BOBRN etc. used for loading loose/bulk commodity.
