1.0 In terms of reference at (i) & (ii) above, Board's approval was communicated for restarting of 25 Tonne axle load operation with such rolling stock as are fit/ certified for 25 Tonne axle load on various notified routes.

2.0 The routes are notified in terms of Annexure-IV of reference (iii) above.

3.0 In terms of Corrigendum No.122 to RMC/PCC/CC+8etc/2020/0 dated 18.11.2024, following route was notified as 25 ton axle route:

Titlagarh(TIG)-Lakholi(LAE) (Excluding) UP&DN

4.0 Matter has been reviewed in the light of South East Central Railway's proposal and the Competent Authority has approved to delete the word 'Excluding' and so modify the above notified routes as under:

• **Titlagarh(TIG)-Lakholi(LAE) section/UP&DN**

5.0 All other details of Corrigendum No.122 to RMC/PCC/CC+8etc/2020/0 dated 18.11.2024 shall remain the same.



8.0 This issues in consultation with Traffic Transportation and Civil Engineering Directorates and with the concurrence of the Finance Directorate of Ministry of Railways.




