2. The above permission is subject to fulfillment of para 10.4 & 10.5 of the AFTO policy.

3. BCACBM rakes are to be run on above routes with condition as stipulated in CRS/GM sanction and letter of respective Zonal Railways.

4. Freight shall be charged as per extant rules.

5. Zonal Railways are advised to ensure that the rakes are not run overdue for examination or maintenance.
