With the approval of the General Manager/East Coast Railway, the following orders are issued.

1. The looking after arrangement in favour of Shri Lingaraj Tripathy, Sr. CDO/PURI for the post of Sr.DME/KUR issued vide PCPO's O.O. No. 34/2023, Dated: 17.02.2023 is terminated.
2. Shri Lingaraj Tripathy, SG/IRSME, presently working as Sr.CDO/PURI (PC-05CO5P015) is transferred and posted as Sr.DME/KUR (PC-05CO5P007).
3. Shri Surendra Kumar Padhi, SS/IRSME, presently working as DME/Chg/KUR (PC-05CO6P003) having been placed in the select list for promotion to JA Grade on ad-hoc basis, is promoted to JAG on ad-hoc basis, transferred and posed as Sr.CDO/PURI vice (2) above.
4. The post of Dy.CME(DSL & DM)/HQ/BBS (PC-05CO5P002), presently lying vacant, is transferred to CRW/MCS and operated as Dy.CME(POH-II).
5. Shri Kansu Sudarsan, SS/IRSME, presently working as WM(Production)/CRW/MCS (PC-05CO6W009), having been placed in the select list for promotion to JA Grade on ad-hoc basis, is promoted to JAG on ad-hoc basis and posed as Dy.CME(POH-II)/CRW/MCS(PC-05CO5P002), against the post arranged at (4) above.
6. The post of Secretary to PCME (PC-05CO5P006) is redesignated as Secretary to PCME & Dy.CME(DSL & DM). This post shall have the combined responsibilities and duties of Secretary to PCME and Dy.CME/DSL & DM.
7. The post of Dy.CME(Freight)/HQ (PC-05CO5P003) is redesignated as Dy.CME(Freight & Planning)/HQ. This post shall have the combined responsibilities and duties pertaining to freight and planning cells.

NB:(i)The JAG (ad-hoc) panel/Select list of officers at Srl No. 3& 5 for their promotion to JAG on ad-hoc basis has been made in Mech. Department vide DS/Conf's letter No.ECoR/GA/Conf/DPC/II/Mech/21 dated 20.03.2023 with the approval of the General Manager/East Coast Railway on 17.03.2023. They are liable to be replaced as and when regular incumbent becomes available. They are entitled for pay as prescribed vide Railway Board's letter No.PC-VII/2017/1/7/5/8 dated 08.08.2019 (RBE No.127/2019). They may exercise option if permissible for fixation of pay as per normal rules.
