His promotion is subject to his not undergoing any punishment under the RS D&A Rules, 1968. He may exercise option for fixation of pay as AEN/Group'B' within one month from the date of his promotion in terms of CPO's Estt.Serial No.231/81 and as per extent rules.

Guru in the 70% Group-B panel of AEN published vide PCPO's Memorandum No. DCPO(G)/Con/Gaz/Gr.B/Engg-70%/Panel/Final(2003-05) dated 09.03.2006 in Civil Engg. Department of ECoR by extending the panel as conveyed by Railway Board vide letter No. E(GP)2006/2/02 dated 09.03.2023.
