With the approval of the Competent Authority, the following orders are issued.

1. The Sr. Scale post of SSO(S&T)/BBS (PC-10CO6P014) which was downgraded to Jr. Scale vide PCPO's O.O.No.Gaz-233/2022 dated: 22.12.2022 is restored back to Sr. Scale.
2. Shri Debashis Mishra, JS/IRSSE, presently working as ASO(S&T)/BBS (PC-10CO6P014) having been placed in the select list for promotion to Sr. Scale on regular basis, is promoted to Sr. Scale on regular basis and posted as SSO(S&T)/BBS against the post at (1) above.
3. The vacant Sr. Scale post of DSTE/Con/JJKR (PC-10CO6P012) is re-designated as DSTE/M/JJKR (PC-10CO6P012).

6. Shri Pothuri Raju, JS/IRSSE, presently working as ASTE/TIG (PC-10CO7P004) having been placed in the select list for promotion to Sr. Scale on ad-hoc basis, is promoted to Sr. Scale on ad-hoc basis and posted as DSTE/M/TIG (PC-10CO6P001) against the post at (5) above.

NB: (i) Officers at Srl No. 2 has been empanelled for regular promotion to Sr. Scale vide memorandum No. ECoR/GA/CONF/DPC/II/S&T/85 dated 19.01.2023. His fixation of pay in Sr. Scale will be made under normal operation of rules.

(ii) Officers at Srl No 4 and 6 have been empanelled for ad hoc promotion to Sr. Scale vide memorandum No. ECoR/GA/CONF/DPC/II/S&T/85 dated 19.01.2023. They are liable to be replaced as and when regular incumbent become available. They are entitled for pay as prescribed vide Railway Board's letter No. PC-VII/2017/1/7/5/8 dated 08.08.2019 (RBE No.127/2019).

(iii) Attention to the above officers should be drawn to the availability of option for fixation of pay as per Railway Board's instructions issued from time to time, so that they are fully aware of this while accepting the promotion.
