Sub: Transfer of Railway employees during Scholastic Session of the Children.

Ref: (i) This office letter No. ECoR/Pers/HQ/R/Transfer/05/21, dtd.03.02.2021.

(ii) ECoRSC's representation dated 19.08.2024, addressed to GM.

Arising out of demands made by ECoRSC vide Agenda item No-49C-01-2020 of 49th ZPNM, demanded that periodical transfer should not be resorted to during academic session of children of the staff being transferred. Accordingly, instructions were issued to all concerned vide this office letter under reference (i) above.

Now, ECoRSC in letter under reference (ii), has alleged that the aforesaid guidelines are not adhered. As a result, Railway employees are facing a lot of problems for admission of their wards in the middle of the scholastic session for the rotational transfer.

Keeping in view of the aforesaid ZPNM decision, it is reiterated that instructions issued vide this office letter under reference (i) above should be adhered to while considering rotational transfer of Railway employees over ECoR.
